1. GENERAL PROVISIONS

2. DEFINITIONS

1. CONTACT FORM - a form available on the website <https://doitinpoland.com/>, enabling the Service User to contact the service provider directly.
2. TERMS AND CONDITIONS - these terms and conditions of the website.
3. SERVICE PROVIDER - **Winged IT Sp. z o. o.**, head office address: ul. Ligocka 103, 40-568 Katowice, Poland, delivery address: ul. Ligocka 103, 40-568 Katowice, Poland entered in the Register of Entrepreneurs under the KRS number: 0000685708, NIP: 6342899277, REGON: 367741723, having share capital in the amount of: 50000 PLN, e-mail address: info@wingedit.pl, Tel.: + 48500000480.
4. SERVICE USER - a natural person, a legal person or an organisational unit without a legal personality, whose legal capacity is granted by law using an electronic service.
5. ELECTRONIC SERVICE - a service provided electronically by the Service Provider to the Service User through the website.
6. NEWSLETTER - an electronic service allowing the Service Provider to subscribe and receive free information from the service provider to the e-mail address provided by the service provider.

3. TYPE AND SCOPE OF ELECTRONIC SERVICES

1. The Service Provider enables you to use Electronic Services via the Service, such as:
 1. using the Contact Form,
 2. using the Newsletter,
2. The Rendering of Electronic Services for the benefit of the Service Users is carried out under the conditions specified in the regulations.

4. CONDITIONS FOR PROVIDING AND CONCLUDING CONTRACTS FOR ELECTRONIC SERVICES

1. The Rendering of Electronic Services referred to in point (A) of Chapter III. 1 of the Terms and Conditions by the Service Provider is free of charge.
2. Period for which the contract is concluded:

1. The contract for the Rendering of an Electronic Service consisting in the possibility of sending a message via Contact Form is concluded for a specified period, and is terminated at the moment of sending the message, or when the recipient ceases to send it.
 2. The contract for the Rendering of an Electronic Service consisting in the use of the Newsletter, is concluded for an indefinite period.
 3. Technical requirements necessary for cooperation with the IT system used by the service provider:
 1. computer with Internet access,
 2. access to e-mail,
 3. web browser,
 4. enabling cookies and Javascript in your web browser.
 4. The Service User is obliged to use the site in a manner consistent with the law and good practices, taking into account the respect for personal property and intellectual property rights of third parties.
 5. The Service User is obliged to enter data in accordance with the actual state.
 6. The Service Provider is prohibited from providing unlawful content.
5. CONDITIONS FOR THE TERMINATION OF CONTRACTS FOR THE RENDERING OF ELECTRONIC SERVICES
1. Termination of the Electronic Service contract:
 1. A contract for the Rendering of an Electronic Service of a continuous and indefinite nature may be terminated (eg. using the Newsletter).
 2. The Service User may terminate the contract with immediate effect and without giving reasons by sending an appropriate statement via e-mail to: info@wingedit.pl
 3. The Service Provider may terminate the contract for the Rendering of an Electronic Service of a continuous and indefinite nature in the event that the service user violates the terms and conditions; in particular, when he provides illegal content after a prior request to cease violations with a reasonable period of time has been unsuccessfully made. In this case, the Agreement expires

after 7 days from the date of submission of the declaration of will to terminate the contract. (termination period).

4. Termination shall cease the legal relationship with effect for the future.

2. The Service Provider and the Service User may terminate the contract for the Rendering of the Electronic Service at any time, by mutual agreement of the parties.

6. COMPLAINTS PROCEDURE

1. Complaints related to the Rendering of Electronic Services by the Service Provider:

1. The Service User may submit complaints related to the Rendering of Electronic Services via the website, by means of an e-mail sent to the following address: info@wingedit.pl

2. The e-mail should provide as much information and circumstances as possible regarding the subject of the complaint, in particular the type and date of the irregularity and contact details. This information will greatly facilitate and speed up the processing of complaints by the Service Provider.

3. The Service Provider will investigate the complaint immediately, no later than within 14 days.

4. The Service Provider's response to the complaint shall be sent to the e-mail address of the Service User, specified in the complaint or in any other manner specified by the Service User.
